Horticultural Applications

Bifenthrin 7.9F Select™ is effective for use on a broad range of insects and mites on trees, shrubs, leafy plants, nonbearing fruit and nut trees. It may also be used on interior plants found in hotels, shopping malls, office buildings and other similar areas. **Bifenthrin 7.9F Select** may be used by itself or in a tank-mix with other products such as insect growth regulators.

Turf Applications

Bifenthrin 7.9F Select can be used as a broadcast treatment on turfgrass for control of many insects including armyworms, cutworms, chinch bugs, ants, and ticks. **Bifenthrin 7.9F Select** may be applied at up to 1 fl. oz. per 1,000 square feet at the discretion of the applicator according to labeled directions for use. Maximum residual control requires the higher treatment rates.

Pest Control on Outside Surfaces and Around Buildings

Livestock and Poultry Buildings and Kennels

Bifenthrin 7.9F Select may be used as a surface spray (including directed spray) and crack and crevice application for control of flies, fleas, beetles, bed bugs, mites and ticks. Usual cleaning of the structure must be completed along with the **Bifenthrin 7.9F Select** application for effective control.
